### Cosmo Ferrites Ltd. reports results for Q2'FY25

**New Delhi, 30th Oct 2024:** Cosmo Ferrites Limited, a leading manufacturer and exporter of Soft Ferrites and an emerging player in wire wound magnetic components today declared its financial results for the quarter ended 30<sup>th</sup> September 2024.

In Q2'FY25, the company witnessed marginal drop in sales revenue compared to the previous quarter due to lower realisation although sales in volume terms remain at similar level. EBITDA margin in Q2'25 compared to previous quarter improved with overhead rationalization.

The government, responding to the company's request, initiated an anti-dumping investigation for import of soft ferrite cores from neighbouring country. The investigation is progressing as per the notified schedule and the results are expected by the end of Dec'24. Any favourable outcome will help improve operating margins and capacity utilization.

“The company has successfully developed couple of new products tailored for higher end applications. The Company has also recently started supplying to ISRO and signed NDA with CSIR-CSIO for the development in higher end applications. The most critical element is to fill-up the capacity and the Company has won multiple programs in the recent past which should help to fill-up some of the idle capacity in a staggered manner profitably. The Company is also in the process of reducing overheads and take price corrections to improve the profitability.”
